# Official Rules Dew Tour

## Dew Tour X Tech Deck Detour Fingerboard Challenge April 15 - June 20, 2020

- 1. Introduction: Weider Publications, LLC (owner and publisher of Dew Tour), ("Sponsor") is offering the Dew Tour X Tech Deck Detour Fingerboard Challenge (the "Contest") in the 50 United States and the District of Columbia and Canada (excluding Quebec) (the "Territory") that begins at 12:01 AM PT April 15, 2020 and ends at 11:59 PM PT on April 20, 2020 (the "Contest Period"). NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS Contest. VOID IN PUERTO RICO AND WHERE PROHIBITED. This Contest is governed by these Official Rules.
- 2. Eligibility: Participant must be at least 13 years of age or older at the time of entry and a resident of the Territory. Persons in the following categories are NOT eligible to participate: any individual who was or is, as of April 15, 2020, (a) an employee, officer, director, agent or independent contractor of Sponsor, its parents, subsidiaries, affiliated companies, or agents; or (b) an immediate family member (defined as spouse, IRS-dependent, or biological, foster, in-law, adoptive, or step-mother, father, sister, brother, daughter, or son) of, or who resides in the same household as, any person in any of the preceding categories.
- 3. Agreement to Official Rules. Contest will be conducted in the Territory by the Sponsor, and each person who participates in the Contest (each a "Participant," "you," "your"), and his or her parent or legal guardian if the Participant is a minor or subject to a guardianship agreement, unconditionally accepts and agrees to comply with, abide by, and have all participation subject to these Official Rules and the decisions of the Sponsor, which shall be binding with respect to all aspect of the Contest in the Territory.

#### 4. How to Enter:

There is one (1) way to enter the Contest. Each Entrant may enter an unlimited number of Submissions, subject in each case to these Official Rules.

Participant may enter this Contest by:

A. Uploading a :15s or less video of a fingerboarding line to participant's public Instagram account during the Entry Period on Wednesday April 15, 2020. The video of the fingerboarding line must be captured by participant while inside the confines of their home and tagging in the caption @dewtour, @techdeck, and #TechDeckDeTour.

If you do not have an Instagram account, you can obtain one for free by visiting <a href="https://www.instagram.com/">https://www.instagram.com/</a> and following the prompts to

obtain an account.

Entries must be received by the Sponsor no later than 11:59 PM EST on April 15, 2020.

By entering on Instagram, you agree that your entry conforms to the Submission Requirements as defined below ("Submission Requirements") and that Sponsor, in its sole discretion, may disqualify you from the Contest if it believes that your Entry fails to conform to the Submission Requirements. Participants must have permission from all individuals that appear in the entry (if any) to use their name and likeness in the entry and to grant the rights set forth herein.

#### Duration of Contest:

- April 15, 2020 Open Qualifier line must be no more than (:15) seconds Total # of competitors will vary based on # of submissions, (1) line anywhere inside participant's home. Qualifying runs may be submitted beginning at 12:01am PT on April 15, 2020. The qualifying line submission window closes at 11:59pm PT on April 15, 2020.
- April 17, 2020 Heat 1 (Round of 16) line must be no more than (:15) seconds (16) fingerboarders, (1) line inside participant's home room TBA. Heat 1 submissions close at 5:00pm PT April 17, 2020.
- April 18, 2020 Heat 2 (Round of 8) line must be no more than (:15) seconds (8) fingerboarders, (1) line inside participant's home room TBA. Heat 2 submissions close at 5:00pm PT April 18, 2020.
- April 19, 2020 Heat 3 (Round of 4) line must be no more than (:15) seconds - (4) fingerboarders, (1) line inside participant's home room TBA. Heat 3 submissions close at 5:00pm PT April 19, 2020.
- April 20, 2020 Heat 4 (Final, Round of 2) line must be no more than (:15) seconds (2) fingerboarders, (1) line inside participant's home room TBA. Heat 4 submissions close at 5:00pm PT April 20, 2020.

\*The Judging Window for the Open Qualifier round will be April 16, 2020 from 9:00am PT to 9:00pm PT or as soon as reasonably practicable for Sponsor.

\*\*The Judging Window for bracketed rounds (Round of 16, 8, 4, 2) will be from 5:00pm PT to 7pm PT immediately following the close of submission window.

\*\*\*Participant submissions selected by the judging panel to advance forward from a round will be notified of their advancement via direct message prior to official public announcement on Dew Tour and Tech Deck Instagram accounts.

#### Contest Format:

- Participants will enter submissions via an open qualifying round April 15, 2020. The qualifying submission window opens at 12:01am PT on April 15, 2020 and closes at 11:59pm PT on April 15, 2020.
- Fingerboarders will be judged on overall impression for each run based on the Judging Criteria outlined in section *Judging Criteria* below.
- The top 16 participant submissions from the open qualifying round on April 15, 2020 will advance to the head-to-head bracketed competition rounds starting on April 17, 2020
- Only 2 fingers may be used when performing and landing tricks during maximum :15 sec line (Example - No 3 fingers used to pop or land tricks)
- At the conclusion of the contest on April 20, 2020, the leaderboard will show top 3 winners - 1st Place, 2nd Place, 3rd Place

MOBILE DEVICES: If you participate via a smart phone or other mobile device, Message and Data Rates may apply. Not all cellular service providers offer the service necessary to participate in this Contest through a mobile device. Please check with your provider for specific capabilities, charges and pricing plans.

5. Submission Requirements: BY SUBMITTING AN ENTRY THROUGH INSTAGRAM, YOU AGREE THAT ANY COMMENT COMPLIES WITH ALL CONDITIONS STATED IN THESE RULES AND ANY TERMS AND GUIDELINES SET BY INSTAGRAM. THE RELEASED PARTIES WILL BEAR NO LIABILITY WHATSOEVER REGARDING THE USE OF YOUR ENTRY OR ANY COMPONENT THEREOF. THE RELEASED PARTIES SHALL BE HELD HARMLESS BY YOU IN THE EVENT IT IS SUBSEQUENTLY DISCOVERED THAT YOU HAVE DEPARTED FROM OR NOT FULLY COMPLIED WITH ANY OF THESE RULES AND/OR THE INSTAGRAM RULES.

By participating in the Contest, each Participant hereby warrants and represents that any comment he/she submits:

- a) is original to him/her;
- b) does not violate any law, statute, ordinance or regulation;
- c) the account must be made be set to public during Entry Period and for a period of at least 15 days after the end of the Entry Period;
- d) will not give rise to any claims whatsoever, including, without limitation, claims of infringement, invasion of privacy or publicity, or infringe on any rights and/or interests of any third party; and
- e) is not defamatory, trade libelous, pornographic or obscene, and further that it will not contain, depict, include, discuss or involve, without limitation, any of the following: nudity; alcohol/drug consumption or smoking; explicit or graphic sexual activity, or sexual innuendo; crude, vulgar or offensive language and/or symbols; derogatory characterizations of any ethnic, racial, sexual, religious or other groups (including, without limitation, any competitors of Sponsor); personal information of individuals, including, without limitation, names, telephone numbers and addresses (physical or electronic); commercial messages, comparisons

or solicitations for products or services other than products of Sponsor; any identifiable third party products, trade-marks, brands and/or logos, other than those of Sponsor); conduct or other activities in violation of these Rules; and/or any other comment that is or could be considered inappropriate, unsuitable or offensive, all as determined by the Sponsor in its sole and absolute discretion.

The Sponsor reserves the right, in its sole and absolute discretion, at any time and for any reason to screen any comment. Any comment that the Sponsor deems, in its sole and absolute discretion, to violate the terms and conditions set forth in these Rules is subject to disqualification. The Sponsor reserves the right, in its sole and absolute discretion at any time and for any reason, to request a Participant to modify, edit and/or re-submit his or her comment in order to ensure that the comment complies with these Rules, or for any other reason. If such an action is necessary at any point during or after the Conte, then the Sponsor reserves the right, in its sole discretion, to take whatever action it deems necessary based on the circumstances – including, without limitation, disqualifying the comment (and therefore the corresponding Entry and/or the associated Participant).

6. SELECTION OF WINNERS: The Winners will be determined by expert judging. During each judging period, each eligible Submission will be judged by a panel of five (5) judges who are experts in the fingerboarding and skateboading industry (the "Judging Panel") to be selected and designated by Dew Tour and Tech Deck. The determinations of the Judging Panel will be final and binding in all respects.

At the conclusion of each Contest Round, the Judging Panel will select the participant submissions that qualify to move to the next round. During the Judging Period, the Judging Panel will select advancing participant submissions and winners using the Judging Criteria set forth below from all the eligible Submissions.

The evaluation of the Judging Panel will carry 100% of the weight for round advancement and winners.

Advancing competitors and/or winners at the end of each round will be announced on Dew Tour's Instagram account and reposted on Tech Deck's Instagram account. Competitors selected by the judging panel to advance forward from each round will be notified of their advancement via Instagram direct message prior to official public announcement on Dew Tour and Tech Deck Instagram accounts.

- 7. JUDGING CRITERIA: The Judging Panel will evaluate each eligible Submission based on the following criteria
  - Aggressive execution of maneuvers
  - Degree of difficulty of maneuvers
  - Variety of maneuvers in line
  - Continuity of run

- Originality and style
- Creative use of features within the home

The Judging Panel will decide the advancing submissions and winners at their sole discretion. At the end of the contest 1st Place, 2nd Place and 3rd Place will have been determined. THE DECISIONS OF THE SPONSORS AND THE JUDGING PANEL ARE FINAL AND BINDING AS TO ALL ENTRANTS.

Prize/Details: A total of Three, (3) Prize Packages will be available for distribution in the Territory. The total Approximate Retail Value ("ARV") of each Prize Package varies for 1st, 2nd and 3rd place. The total Approximate Retail Value ("ARV") for 1st Place is \$700. The total Approximate Retail Value ("ARV") for 2nd Place is \$325. The total Approximate Retail Value ("ARV") for 3rd Place is \$170.

The Sponsor will attempt to contact  $1_{\text{st}}$ ,  $2_{\text{nd}}$ , and  $3_{\text{rd}}$  place winner of a prize by Instagram Direct Messages. If the potential winner cannot be reached within seven (7) days after the first attempt to contact such potential winner, Sponsor shall have the right, but not the obligation, to award the applicable Prize to another participant selected from among the remaining eligible entries. A potential winner may be requested to provide Sponsor with proof that the potential winner is the authorized account holder of the e-mail address associated with the winning entry.
